## Gardens Around the Community

While out tending to the beautiful beds in our community Kim, Helen, and I find inspiration we would like to share with you.

Hydrangeas are putting on their summer show of color. There are a variety of shrubs that can be grown in tree form. When a shrub is grown in tree form it is called a standard. Hydrangea and Lilac Standards are within our community. There is even a Hibiscus Standard at the atrium, located at the Seasons Lakehouse. I do not think we have a Rose of Sharon Standard.

It is important to prune the trunk to keep the tree form. Keeping the trunk clean will allow your Hydrangea, Lilac, or Rose of Sharon to push energy up into the canopy.

The canopy is where the standard will create its blooms. When a standard is not maintained, it wastes a lot of energy pushing unwanted growth on the trunk. This can affect the amount of blooms up in the canopy. So, if you enjoy a colorful show, be sure to keep the trunk of your standard pruned.

The Porter County entrance at the end of Four Seasons Parkway has been planted. The House and Garden club are the benefactors of the plantings. A variety of re-blooming day lilies, allium millennium, ornamental grass, hibiscus, ever green shrubs, sedums



and Tuscon Gold Heliopsis are in the larger section. The smaller area is a pollinator garden.

For those of you who love to feed the birds, the Indiana Department of Natural Resources has asked every Indiana resident to take down their bird feeders, including hummingbird feeders, as well as bird baths. Songbirds are getting sick and dying. Please do your part to protect the wildlife we all love. Maybe you will be inspired to grow some Black-Eyed Susan (Rudbekia), Cardinal Flower (Lobelia), or Sunflowers, just to name a few.

There is plenty of food from flowers and insects that the birds can eat. As for all of us who enjoy them, maybe we will have a harder time adjusting than they will.

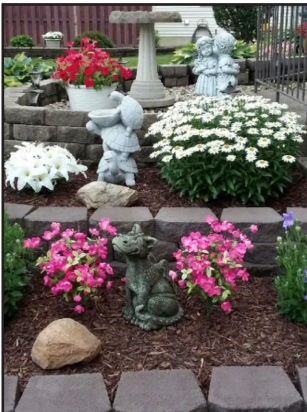

## Golf Course Cart Paths for Golfers Only!

As a reminder to all residents, utilizing the golf course cart paths for anything other than its intended use is prohibited.

The paved cart path at the front gate that passes around the back of Hole #17 Green is an access path used to go to and from the shopping center west of LOFS. However, carts must exit onto the entrance road and enter through the

automated gates of the community instead of continuing travel onto the golf course's 18th Hole

Tickets will be issued for trespassing on the golf course property if found using the course as an exit and entry path. Fishing on the golf course property is prohibited unless accessed through a residential property.

These rules are in place for

both safety to residents and for preventing interruptions to golfers. Golf Course Rangers and Security Officers will be cracking down on those that choose to ignore signs and continue to use the cart paths for running, jogging, biking, dog walking or non-golfing traffic with the issuance of citations at any time of the day.

Security License

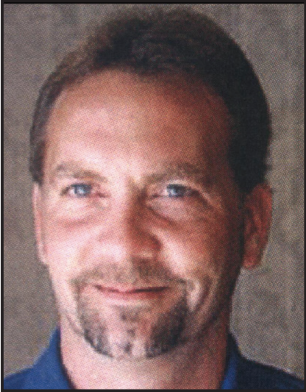

Lakefront Property Owners:

All lakefront lots need to have a lot number affixed to the docks or displayed within 10 feet of your shoreline facing the lake. Numbers and letters should be at least four inches in height and contrasting to make them clearly visible to emergency personnel and the Lakes Department.

This includes Lake on the Green, Lake Holiday, and Big Bass Lake. Be sure when complying with this rule that you use your Lot Number, not your address number. If you do not know your Lot Number you can obtain it from the POA office or the

Lakes Department.

Make sure that your docks and shorelines are in good condition. Please contact the Lakes Department to give us the status of any repairs that need to be made. If you have any damage or overgrowth to your shoreline or seawalls and don't know what route to take for repairs, also contact us so that we may point you in the right direction. The Lakes Department has been out checking docks, shorelines, and lot numbers this month and has sent out letters and will continue to do so if you are not in compliance.

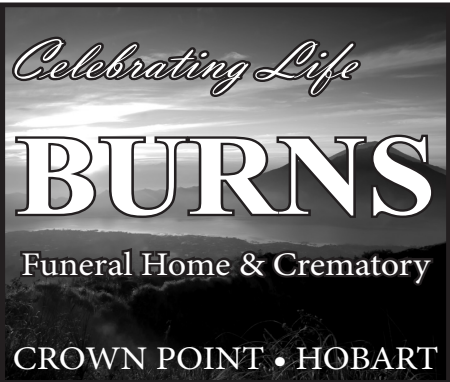

## Porter Township School Corporation online student registration announced

The Porter Township School Corporation announced online student registration for the 2021-22 school year will be available through Harmony family accounts for all returning students began on Monday, July 26.

Returning students with an address change must also provide proof of residency, such as a utility bill, tax forms, or other.

New students to the district should contact their main offices at the following numbers to schedule an appointment:

All new students to the district must provide a certified birth certificate, immunization record and proof of residency. Additional registration information is posted online at the district's webpage.

All PTSC students are required to register and pay book rental fees. Book rental fees for the 2021-22 school year are: Kindergarten, \$136; 1st Grade, \$125; 2nd Grade, \$113; 3rd Grade, \$122; 4th Grade, \$100.25; 5th Grade, \$100.25; 6th Grade, \$117.00; 7th Grade: \$111.90; and 8th Grade, \$96.65.

Additional middle school fees are based upon class schedule: 7th and 8th Grade Art: \$8; Choir and Band: \$9.00. Book rental fees for Boone Grove High School students are based upon class schedule and are provided at registration.

The first day of school for students is Wednesday, August 11 and will begin with a 30-minute delayed start as scheduled for every Wednesday throughout the school year.

Fields of interest which will be considered for funding include Animal Related, Arts and Culture, Community Improvement, Economic Development, Education, Environmental, Food/Nutrition/Agriculture, Health and Human Services, Housing and Shelter, Public Safety, Recreation, Religion Related, and Youth Development.

“The Crown Point Community Foundation is interested in funding projects that will improve the quality of life for citizens in the South Lake County area,” said Mary Nielsen, president of the CPCF.

Eligible organizations may apply for grants on the CPCF online grant platform. Grant applications will be accepted through September 1, 2021.

The CPCF awards grants from the unrestricted community funds held in the CPCF Unrestricted Fund three times a year. The three application cycles are February 1, June 1, and September 1. Only one grant application per organization or agency will be eligi-

ble within a 12-month period. Communities included are Crown Point, Winfield, Cedar Lake, and Lowell.

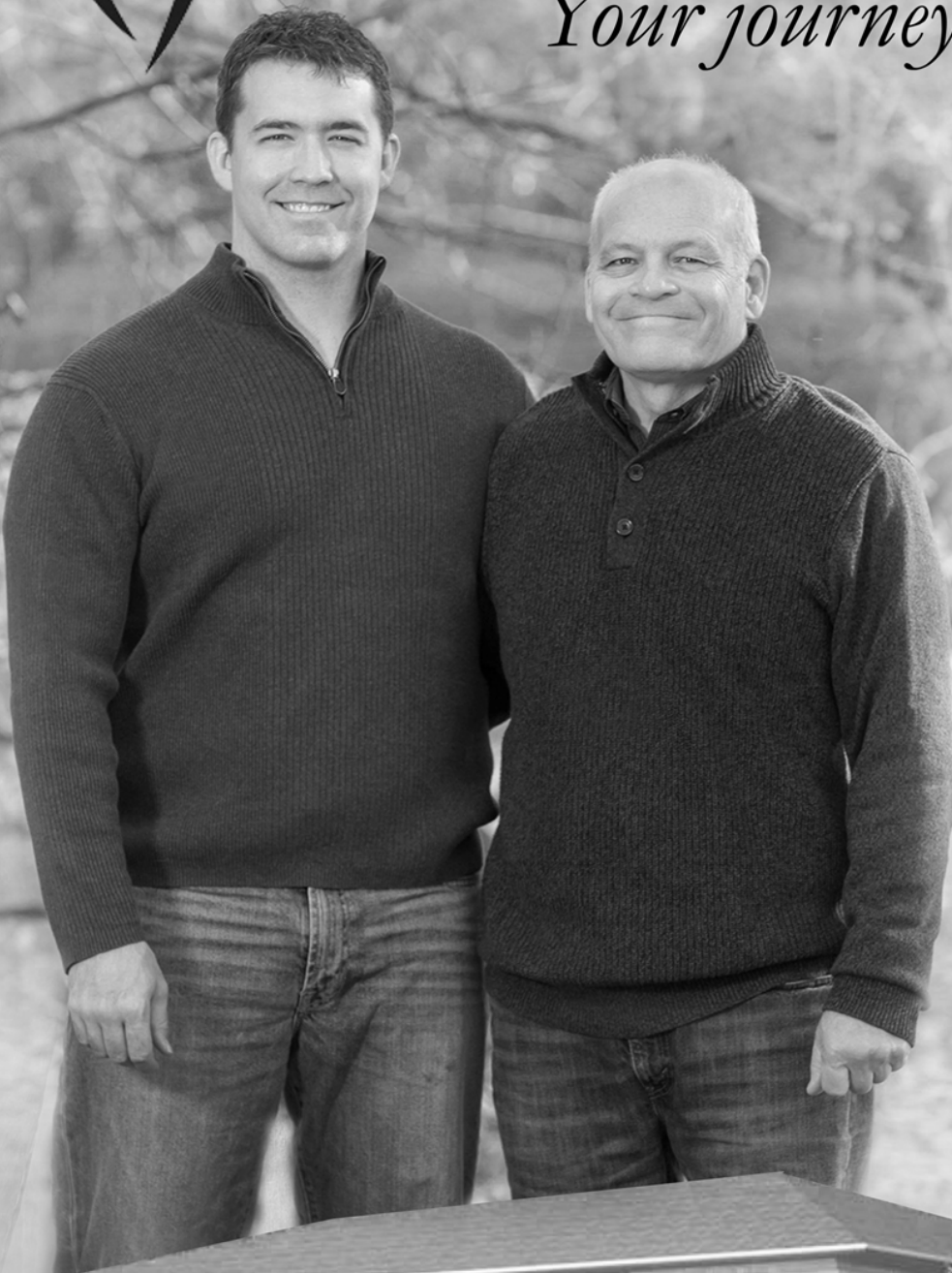

Liverpool, not Crown Point, was the first county seat of Lake County

Did you know that Lake County’s first county seat was not Crown Point, but Liverpool? And where is Liverpool, you ask? Not too many people know.

At the session of the Legislature of Indiana of 1835-36, the territory north of the Kankakee River and west of LaPorte County was divided into areas called Porter and Lake. Porter County was organized in 1835, with Lake attached to it.

In the spring of 1837, Lake County was formed and divided into three townships, North, Center, and South. Solon Robinson, an early settler in the area and considered to be the founder of Crown Point, was named justice of the peace of Center Township.

After Lake County was organized and before the county seat was permanently

located, Solon Robinson believed the county seat should be in the geographical center of the county. As his own expense, he built a two-story log house, gave it to the county for a courthouse and jail, and he also donated land for a public square. He must have had the foresight of things to come, as he named his settlement as Lake Court House, later to be called Crown Point.

As settlers continued to come to Lake County, small villages were formed, including one called West Point, near the outlet of Cedar Lake on its east shore, and one called Liverpool, now part of Lake Station. As a result, these communities, West Point, Liverpool, and Lake Court House, each coveted to be the county seat.

By 1839, the commissioner’s court, the circuit court, and county offices were using the log court house located at Lake Court House. By some conniving or political influence, however,

Liverpool was selected as the county seat, where a log courthouse was partially built on a ridge on the north bank of Deep River.

This town of Liverpool, where lots were first sold in 1836 and developed by individuals who came from England. They felt this location, with a ferry across the river and a road on a stage-coach route from Detroit to Chicago, would be a successful location for commerce.

Because of the moving of the county seat to Liverpool, public indignation was so aroused that the State Legislature was later induced to appoint another commission, that, after due investigation, recommended that the seat of county government be moved back to the town in the center of the county.

It has remained there since 1840, the year the town was named Crown Point. Liverpool, by contrast, failed to develop and faded into oblivion, caused in part by the Panic of 1837. The log

courthouse building there was later sold, floated down Deep River, then west on the Little Calumet River to Blue Island IL, where it became a tavern in 1846.

The old frame courthouse in Crown Point erected in 1837

proved inadequate, although used until 1850. In that year, a new brick courthouse was commenced and completed in 1853; however, it also was insufficient to serve the needs of the growing county.

As a result, a new Crown Point courthouse was started in 1878 with architecture of

the Victorian Period combining Romanesque and Georgian styles. In 1907, two-story extensions were to the north and south ends. This courthouse, still prominent today, was used until 1974, when the current County Government Center was built.

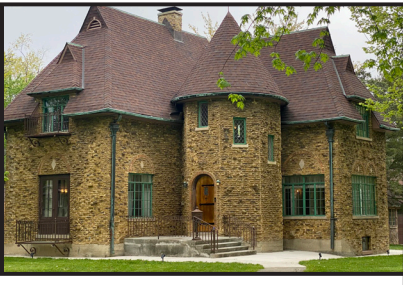

# Public Safety

Use of Golf Course and

There have been a lot of questions about the new gate system and how golf carts will have to enter. As long as there is a current and visible LOFS golf cart sticker affixed to the golf cart the Security staff will be able to open the gate for you.

Some entering the community have been found using the golf cart path to do so. Please understand that this is a dangerous act you are taking as you could be hit by a golf ball.

The course should only be used by individuals who are playing the game, maintaining the course, or enforcing gameplay and the rules. All other people found on the course are subject to fines being issued in accordance with

the POA rules.

## Automated Gate System

As a resident, entering the community through the new gate system properly can make all the difference. This goes for all of our automated entry points of the community as well. Each gate has a sign posted informing everyone entering that they need to wait for the gate to reset prior to proceeding.

These signs are posted in the same location as each posted stop sign, but unfortunately these stop signs are often ignored, and there are times when the gates have come down on vehicles. Most of the time when this happens its due to either a piggyback attempted entry or a barcode not reading as the resident drives through unaware that the gate is coming down, or when they are under

the belief that they have time to make it through.

We all need to keep it in our minds that there is no guarantee that the barcode attached to our vehicles will read each and every time we enter; especially when some are entering at a higher rate of speed than they should be instead of stopping as the sign directs them to.

By stopping and waiting for the gate to reset, not only are we ensuring that our barcodes are actually read, allowing the gate to open, but we are also saving the system of wear-and-tear. When people don't allow the gate to fully reset, the gate is forced to jolt itself back to an upright position, adding stress on the gears, pins, and drives inside the units.

I have heard people try to compare our gate systems to that of the toll roads. There is a difference: those gates do come back to a reset prior to going back up because it takes our money or pass to do so.

So it's this, along with people breaking our gates just to enter, on why they appear to always be inoperable or not functioning the correct way. Yes, those that damage these gates intentionally end up paying in fines when caught, but it's when residential misuse damages these gates that we are all forced into paying.

Please slow down, wait for the gate to reset, and slowly enter through to the community.

## POA Property Damage

Over the past several months, unknown individuals have been destroying the POA property at our parks, bathhouses, and beaches. We have found the Lion's Park bathhouse toilet destroyed three separate times, someone has lit unknown material on fire inside the bathhouses, the main doors have been kicked inside and out, and now stones thrown at the outside area of the door causing them to be dented.

The Sandy Beach bathhouse was recently vandal-

ized when someone decided to tear the stall door off from the hinges. Prior to that, the main doors were kicked in, stall doors were kicked and bent, and the toilets were tampered with and damaged.

Recently, while an officer was checking on the Lion's Park bathhouse, he found four individuals (male and female) inside the bathhouse claiming they were not doing anything wrong and at that time no damage was found. However, there is no reason why four people, especially both males and females, need to be in a bathroom at the same time, and I am sure if the parents of these kids found out they would more than likely agree.

Now, we have seen the social media posts about putting cameras in these areas in order to record the person(s) doing this but it's not possible and here is why.

Yes, I will see the people that are going in and out of these areas, but unless someone has witnessed the act taking place, how am I to know who from those groups are

actually responsible for the possible damage?

Then there is the invasion of privacy issue, because we all know a camera cannot be pointed directly at the building or doorway, so most of the time I would just see the sides or backs of the individuals as they enter and leave.

There is also the need to have an area where a camera system and its recorder can be housed in order to collect the video of these areas.

Now I am open for ideas on ways to curtail these vandalizing acts from continuing and am asking the community for help with those ideas.

Since my staff cannot obviously be everywhere at the same time, I would also ask that the community help keep an eye on these areas for kids or adults who may be up to no good. If you see or hear anything, please contact this department immediately so we can finally catch and hold those people responsible for their actions.



# Crown Point Community Foundation awards grants for its most recent cycle

The Crown Point Community Foundation awarded \$69,102.00 in grants to the community as part of its most recent grant cycle.

The Crown Point Community Foundation awards grants from the unrestricted community funds held in the CPCF Unrestricted Fund three times a year. The three application cycles are February 1, June 1, and September 1. Only one grant application per organization or agency will be eligible within a 12-month period.

These 17 grants will enrich the lives of residents throughout South Lake County (Crown Point, Winfield, Cedar Lake, and Lowell), from helping Loves Moves Us with support for a program of nurturing, educating, and supporting foster families to helping Open Hearts Therapeutic Riding Center with Funding for safety, supplies and instructor for Open Hearts Horse therapy program.

Unrestricted community grants are made possible by donors who create funds to support South Lake County causes and entrust the CPCF to allocate those funds to a broad range of community projects and needs.

The June 1 grant cycle recipients were:

- Cedar Lake Youth Baseball - \$3,000 to replace the scoreboard on their Minor League Field.
- Chasing Dreams - \$5,266 to help fund the Dream Creative Summer Camp.
- CPCSC/Birth to School program - \$4,800 to help fund educational resources and supplies for early childhood learners.
- CPCSC/Winfield Elementary School - \$1,000 to introduce and integrate developmentally appropriate STEM education, specifically coding and robotics to K-2 student body.
- Hoosiers Feeding the Hungry - \$5,000 to pay for the processing of approximately 3,500 pounds of donated large game and livestock within South Lake County, providing 14,000 more meals for hunger relief.
- In-Pact, Inc. - \$3,718 to update antiquated printers.

## ‘Dark-Sky Havens’ are essential, and there’s a certified one in Northwest Indiana

A bright moon hangs over the clear, terrestrial night sky permeated by winking stars, illuminating the town below with various hues of blue. While some can only fantasize of these beautiful night settings, these nighttime skies do in fact exist—in what is commonly known as ‘dark-sky havens’.

Even more, reserving natural nighttime darkness is a worthwhile investment for public well-being.

“A view of the night sky can soothe the soul,” says John Barentine, astronomer and policy director of International Dark-Sky Association. “In an era when so many people are suffering from the sensory overload of modern life, as well as what psychologists are calling ‘nature deficit syndrome,’ the night sky offers calm, quiet contemplation.”

According to the International Dark-Sky Association, the nearest dark sky haven to Winfield-LOFS is in Beverly Shores, Indiana.

In considering the necessity of these dark sky havens, we must first examine why most night skies are not all like this in the first place.

In most populated, industrialized areas, artificial light from sources ranging from streetlights to factories to commercial properties cause intensive light pollution—casting a dusky yellow stain over the sky’s natural glow.

This excessive artificial light cannot only harm wildlife and the earth’s atmosphere, but also people. For example, blue LED light can disrupt sleep rhythm and increase risk of cardiovascular disease, and cancer, according to the American Medical Association. Thus, many environmental advocates have pushed for state-level legislation on limiting artificial light, particularly in places like Colorado.

In addition to local legislation to restrict light pollution, acquiring a dark sky status requires direct effort from an entire community. While local governments need to measure light levels regularly and curtail public lights, community residents must reduce their own light usage—especially for any outdoor lighting that can spread to other properties.

On a wider scale, residents can implement smarter, greener lighting with LED technology, which can reduce both your electricity bill and carbon footprint by maximizing energy efficiency, which consequently lowers greenhouse gas emissions from power plants.

Reducing light pollution and creating dark sky havens can be important elements in environmental preservation, economic development and public health. In many rural areas, dark sky initiatives promote tourism for stargazing and meteor-shower watching — luring more visitors and thus more money.

Though the International Dark-Sky Association’s standards for managing artificial light are high and certification can take years, dark sky zone applications have expanded widely in Colorado, including the towns of Crestone, Cuchara, Paonia, Pagosa Springs, Naturita, Nucla and La Veta. In the surrounding Rocky Mountain region, towns in states like Arizona, Idaho, Montana, Nevada, New Mexico, Utah, and Wyoming have filed at least 10 applications for dark sky certification. Along with the 25 dark sky towns in the U.S. that you can visit, there are also 77 dark sky designated parks around the nation where you can lay out a blanket after sunset and bask in the nocturnal wonders of starry nights.

# Have fun, but make water safety a priority this summer

In the midst of swimming season, Indiana Conservation Officers remind Hoosiers to make safety a priority when recreating around bodies of water.

“Even when fun is your main focus, always recognize the danger water poses, even to strong swimmers or experienced boaters,” said Capt. Jet Quillen of DNR Law Enforcement.

If you are going to be recreating around water, follow these basic safety tips:

- Discuss the dangers of water with your family and loved ones before going out.
- Wear a lifejacket.
- Tell someone where you are going and when you will return.
- Go with a buddy.
- Do not venture around flooded or fast-moving waterways.
- Avoid alcohol.

In addition to basic water safety, Indiana Conservation Officers also stress the im-

portance of boating safety and remind boaters to know the rules of the water.

Reducing a boat’s speed in unfamiliar areas and being aware of unusual water conditions respective to the size and type of boat are not only safety tips, but also important environmental consid-

erations. Regardless of your boat type, doing an initial assessment of water levels and current speed are essential.

Designate a sober boat operator. Alcohol causes impaired balance, blurred vision, poor coordination, impaired judgement, and slower reaction time. These impairments can be magnified by wave action, sun exposure, and wind.

It is illegal to operate a motorboat or personal watercraft in Indiana while intoxicated due to alcohol or drugs. Indiana law defines intoxication as having a blood alcohol level of 0.08% or greater.

A lifejacket should be United States Coast Guard (See *Water* Page 13)

## Lakes of the Four Seasons Junior Golf Scholarship Program

In an effort, to assist Lakes of the Four Seasons Junior Golf Members further their education, the Lakes of the Four Seasons Men’s Golf Association has established a scholarship program beginning with applicants in their Junior or Senior year in high school for 2021 and attending a University in the Fall of 2021-22.

**There will be 2 - \$1,000.00 scholarships awarded (1 male and 1 female scholarship)**

Qualifications:

1. Applicants must be current LOFS residents, or have parents or legal guardians, who are LOFS residents in good standing of the Lakes of the Four Seasons at the time of application.
2. Applicants must have participated in the Lakes of the Four Seasons Junior Golf Program for at least one year.
3. Applicants must graduate high school in the same year or following year they are applying.
4. Applicants must be attending a University in the same or following year they are applying.
5. Applicants must **submit an application** to verify they are eligible.
6. Applicants must submit an essay, no more than 500 words, regarding the impact that the game of golf has had on his or her life and how they anticipate the game and its lessons will impact their future.
7. Applicants must submit their application and essay by August 15, 2021 of the year applying.

A committee consisting of the Lakes of the Four Seasons Men’s Golf Association, and the Head of the Lakes of the Four Seasons Junior Golf Program shall determine the recipients of the Scholarships. The committee members shall rank applicants of each sex based on their application and essay, with the number one being that which they prefer the most. The male applicant and the female applicant receiving the lowest total when all committee members’ rankings are added together shall be deemed the winners. In the event persons of both sexes do not apply, 2 scholarships may be awarded to those that did apply regardless of sex, if so, decided by majority vote of the Lakes of the Four Seasons Men’s Golf Association. In the event any committee member is related to an applicant, that member shall recuse himself or herself from that vote to prevent any appearance of impropriety. The Treasurer of the Lakes of the Four Seasons Men’s Golf Association Board shall make checks for the Scholarships payable only to the University that the winning applicant(s) will be attending. The renewal of this program shall be decided annually by majority vote of the LOFS Men’s Golf Association Board. It shall be the duty of the Vice President of the LOFS Men’s Golf Association Board to promote and coordinate this program annually to scholarship candidates.

The final month of summer has arrived. August is the start of the transition into the fall season. The start of the month the weather is traditionally very warm and humid. Once we get to about the halfway mark, the nights begin to cool down and the days get a little shorter.

The high temperatures for the day may reach upper 80s or the 90s but it is for a short period of time. This allows the turf to start to recover from the summer stress. The play also starts to slow down when the kids go back to school which also helps. So

far, the course has handled the extreme weather changes well.

This fall, many of my employees are going back to school, either as a student or a teacher. This will make maintaining the course much more difficult.

The rough, fairways, green and tee banks will be cut as they normally are. Changing the cups, mowing of the tees and greens, raking the bunkers, and trimming are going to be the challenge this fall, especially on the weekends.

I will have to change cups and move tee markers the night before so we can mow greens in the morning and

stay ahead of play. Usually, we have one person change cups, two mow greens, two rake bunkers, and one move tee markers and empty garbage.

We are going to do the best we can to keep up with the daily maintenance. Any projects will have to wait until late fall or early winter. We maintain the course first and then do any projects.

If you know a college kid, or anyone looking for a part-time job and who has a driver's license looking for work, let me know. We will be flexible with the number of hours needed.

Get out and enjoy the warm weather; fall is around the corner. Cool days and leaves falling will be here before we know it.

## ‘SWELL: A Group Exhibition on Scaffolding’ on display through August 28

South Shore Arts is presenting the summer exhibit, ‘SWELL: A Group Exhibition on Scaffolding’, curated by Lauren M. Pacheco. SWELL is unconcerned with boundaries but, rather, attempts to recreate a space within a space. Secondary to the artworks themselves is a conversation in challenging aesthetics and assemblies of what exhibits can and should represent—a new way of thinking to help change the way we see and interact with space, curator, and artist, according to the organization.

Pacheco shares this insight on her curatorial project: “Sculptural installations have the power to confront traditional understandings of art production and material history. Within South Shore Arts’ expansive gallery, fabric walls show signs of something that has already happened. As a curatorial intervention, this site-specific exhibition intends to connect the usual and unusual, familiar, and unfamiliar by bringing together artwork, and objects.”

She goes on to say that “the scaffolding system is a timely metaphor for our post-pandemic world. The scaffold, ubiquitous “furniture” seen in urban and rural landscapes, most commonly recognized as construction site infrastructure, provides support or reinforces during building, rebuilding, or preserving.”

SWELL incorporates 37

Chicagoland and Northwest Indiana artists with individual works that drive discourse and critical art practice. Pacheco emphasizes, “My curatorial vision stresses a necessity to exhibit a diverse representation of living artists in spaces, places and institutions that have histories of exclusionary practices based upon race, geography, and gender. I’m very proud to work with a group of artists and creatives in SWELL that include fourteen black, indigenous, and other people of color (BIPOC) and fifteen women.” Additionally, the exhibition features creative practitioners who work across disciplines that are peculiar, provocative, and beautiful.

Participating artists include Chad Kouri, Bishal Manandhar, Marcos Raya, Sydnie Jimenez, Rodrigo Lara, Alison Wade, Carlson Garcia Collective, JB Daniel, Kelly Knaga, and others.

Lauren M. Pacheco is a Mexican-American civic practice artist and cultural worker with over fifteen years of arts administration, curation, and project management experience. Many of her projects are interested in space, people, and social impact. Today, Pacheco serves as a resource to policymakers and institutions in the public dialogue about issues that impact artists and creative enterprises. She is an associate faculty lecturer and the director of Arts Programming

and Engagement at Indiana University Northwest in the School of the Arts.

SWELL: A Group Exhibition on Scaffolding will run through August 28 in South Shore Arts’ main gallery at The Center of Visual & Performing Arts in Munster. The exhibit is free and open to the public.
