Boat/ Boat Trailer Storage

- Boat and Boat Trailers **ONLY**
- Space is limited; the storage area will hold approximately 50 boats/ boat trailers
- The cost is \$15.00 per foot.
- Must be renewed annually.
- Location: 3861 Kingsway Dr. Crown Point, IN 46307
- Each boat/boat trailer must be stored on the site or area designated by LOFSPOA
- Each boat/boat trailer must be stored so that it does not obstruct the placement of other boats or boat trailers.
- Each boat/boat trailer must be properly stored and supported in such a way as to not create a hazard.
- The Storage sticker (STO with number) must be placed somewhere on front of trailer so it can be seen. If boat is stored on supports without trailer; sticker must be placed on front of boat so it can be seen.
- If you store your pontoon on blocks or the like you must provide those items.
- Once the boat and or boat trailer has been stored for the winter it will remain on site until removed in the spring. You may bring the boat trailer back to the storage area for summer storage if you pay the fee.
- Property owners wishing to use this amenity agree to hold LOFSPOA harmless for any damages or other expenses incurred if LOFSPOA exercises its rights to move a boat for non-compliance with the above terms.
- Property owners must show proof of insurance on their boat and/or boat trailer against loss or damage and liability coverage for personal injuries.
- Facility hours of operation (See below) are the only times that boats and or boat trailers can be delivered or removed. Operations director must have one hour notice prior to you picking up or delivering your boat and or boat trailer. Office number (219) 988-4461 or mobile number (219) 323-0699.
- Summer hours of operation (1st Saturday of May – last Saturday of October): 7:00 am - 3:30 pm Monday through Friday and 7:00 am – Noon on Saturdays
- Winter hours of operation (1st week of November – 1st week of May): 7:00 am – 3:30 pm Monday through Friday.

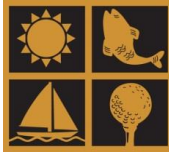
