

LAKES OF THE FOUR SEASONS DECAL AND BARCODE PLACEMENT RULES

Residents of Lakes of the Four Seasons need to be aware that to use any motorized vehicle within our community, the following rules must be followed:

- ❑ You **MUST** have a valid drivers license.
- ❑ You **MUST** have current insurance on vehicle being driven.
- ❑ You **MUST** have a current LOFS POA barcode to enter all automated entrances, except the guest lane at the main entrance.
- ❑ Only the **CURRENT** LOFS POA decal or barcode is allowed to be on a vehicle at any one time. All others **MUST** be removed. LOFS decals or barcodes **MUST** be removed when the vehicle is sold.
- ❑ You may use LOFS streets in a properly licensed and insured car, truck or motorcycle without a ~~POA~~ LOFS decal or barcode, but you **MUST** use the guest lane at the main entrance to enter.

You can obtain the proper LOFS POA decal or barcode for your vehicle by taking your current registration to the LOFS POA office and paying the required fee. You must **NOT** have a balance over 30 days old to receive the proper decal or barcode. Placement of the current LOFS POA decal or barcode requires that they be permanently affixed to the locations described below. Anywhere else is a violation resulting in a fine of \$50.00.

Cars and Trucks: Permanently affixed to any of the left (driver's) side windows out of your line of site for driving purposes. **YOU ARE NOT ALLOWED TO WAIVE THE LOFS POA BARCODE BY ANY MEANS IN FRONT OF ANY OF THE BARCODE SCANNERS TO OPERATE ANY OF THE AUTOMATED GATES.**

Golf Carts:

- ❑ **Golf Cart Decal/ Golf Cart Trail Fee Decal:** Affixed to the bottom of driver's side windshield. If there is no windshield then place anywhere visible on front of the driver's side of golf cart.
- ❑ **Golf Cart Trail Fee Decal:** Affixed to the right front bumper. If no bumper on the right front, visible to anyone in front of the golf cart.

BOATS

- ❑ **Boat decal:** Affixed on the rear and to the right (starboard) side, above the waterline.
- ❑ **Rental Dock Decal:** Affixed directly adjacent to the current boat decal.

PERSONAL WATERCRAFT: affixed on the front and to the right (starboard) side, above the waterline.

BOAT TRAILER: Affixed on the left side of the trailer near the winch. These decals are free (one per trailer).

MOTORCYCLES: affixed to the left side. **ARE NOT ALLOWED TO WAIVE THE LOFS POA BARCODE BY ANY MEANS IN FRONT OF ANY OF THE BARCODE SCANNERS TO OPERATE ANY OF THE AUTOMATED GATES.**

The initial fine for violating this policy falls under all other Covenants/ Bylaws/ Resolutions/ Rules of the LOFS POA Fine Structure.

A daily fine of \$50.00 will be assessed for violation of this policy until brought into compliance.
