We would like to thank everyone who attended this awesome event! A great time was had by all! We certainly appreciated all the positive feedback!

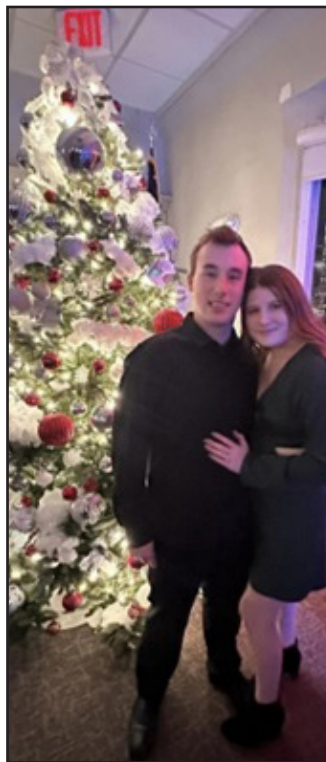
"Thank You" to Michelle Fuscoe, the Lakehouse staff and to our very own awesome

# Community Manager's Message

When the Preliminary Budget was presented on December 11, 2023 we had not received the quotes for insurance. We finally received them on December 22. The General Liability and Umbrella insurance more than doubled in cost. Natural disasters, previous and current frivolous lawsuits contributed to this major increase. In an attempt to keep a dues increase to a minimum the POA Board of Directors made cuts to the Preliminary Budget and placed some equipment and capital improvements into a 5-year loan for the 2024-2025 Budget. Unfortunately, the dues still needed to be increased by \$125.00 to cover the insurance costs and balance the budget.

The 2024-2025 annual assessment for the POA is set at \$1,700. Residents may begin paying the annual assessment on Friday, March 1st this year. Assessments must be paid on or before Wednesday, May 1st. Payments received after this date are considered delinquent and will accrue a \$50 late fee and interest charges.

A packet will be mailed to each homeowner of record in the middle of February. Included in the packet is a pay by mail form that may be used.

## Quarterly or Half Payment Plans

Property owners will continue to have the option to make quarterly payments for their dues with a \$75 upfront application and processing fee and the first quarterly payment. You need to be current on your POA account to participate. The first quarterly payment must be made on or

before Wednesday, May 1st. Failure to stay current on any of the quarterly payments will render the plan void and the remainder owed will be applied to your account.

We will continue to offer the half payment option as well. This option requires a \$50 upfront application and processing fee and the first half of dues by Wednesday, May 1st. The second installment is due on or before Thursday, October 31, to avoid a \$50 penalty.

If you want to utilize one of these payment plans you MUST complete and submit one of the payment plan applications by 4:00 pm Thursday, March 21st; Payment is not necessary on this date but the POA office needs to know ahead of time so the proper amount can be billed to your account. This will allow you to make these payments online through the LOFS Website.

## Vehicle Barcodes

We will NOT utilize the hologram sticker this year. Please remove the old 2023 hologram.

You can keep your existing barcode on your vehicle.

We will be offering black barcodes with no lettering. We still have some of the white ones with LOFS on them.

If you need a new barcode for whatever reason, they will cost \$20 each. We will not be offering any free barcodes.

Just a reminder, if your dues are not paid on time your barcodes will be deactivated and it will no longer allow you access through the automated gates until your account is made current.

Vehicle Barcode Variances will no longer be issued. The current ones will expire May

1, 2024. If you are unable to place a barcode on your vehicle for certain reasons or you just don't want to place a barcode on your vehicle then you will need to check in with the gate attendant at the main entrance every time you want to enter the community. You also have the option of sending yourself a QR code through the Dwelling Live website each time you want to enter. You must set up your members account on Dwelling Live to utilize this process. The POA office staff can help with the installation process. You will need to provide a working email (if we don't already have one for you). You will then be able to receive a QR code to your smart phone via text that you will scan at one of the three scanners at all three entrances. Some cell phone carriers block these types of text messages so you may need to contact your cell phone carrier and request that they allow these messages through.

## Golf Carts Must be Insured to Purchase Sticker

Due to increases in liability insurance and requirements to just keep insurance, residents will need to provide proof of insurance on their golf carts and must sign a waiver in order to purchase a Golf Cart sticker so they can be driven on the streets within the Lakes of the Four Seasons.

Your insurance provider may ask for the serial number of your cart. If you don't have the dealer supplied documentation for your golf cart you should be able to find the serial number, on most models, in or under the glovebox, under the seat, on the steering column, or on the foot well. If you are unable to find it, you will need to contact the dealer to see if they can provide you with documentation. Some insurance carriers will cover

golf carts if they are driven to and from the golf course for a round of golf, but they will not be covered if you drive it anywhere else.

Make sure you send the signed waiver and a copy of insurance that proves your golf cart is insured for driving on the streets throughout the community when you mail all of your documentation to the POA Office.

## No Temporary Golf Cart Passes

The POA will no longer offer temporary golf cart passes to residents that rent or borrow them from outside sources during the 4th of July Holiday or any other time.

## The POA Office Will be Open by Appointment Only During "Dues Season"

Effective Friday, March 1, 2024, the POA office will be open by appointment only. The office will resume normal operations on Thursday, May 2, 2024.

The POA office staff can accept and process more payments for dues and amenities by phone, email and through the website instead of people congregating in the hallway and talking over one another at the POA office.

Dues payments can be made over the phone by calling 219-988-2581 or by U.S. Mail by completing the Pay by Mail Form and sending the necessary paperwork to receive your stickers.

You may also pay online through your member's account through the LOFS website.

Copies of your registrations, proof of insurance, any other necessary documentation and the Pay by Mail Form can be emailed to [statements@lofs.org](mailto:statements@lofs.org)

We will mail your stickers to you if applicable.

If you absolutely need to see us in person let us know and we will work with you to set up an appointment.

## Shelter Rental

Pavilion rental will continue to be on a first come first served basis after you make your dues payment.

A sign-up sheet will be made available in front of the Seasons Lakehouse at 9 a.m. until Noon on Friday, March 1, 2024.

# Inside the Gates with the LOFS Security Department

Happy February from your favorite Security Department. This year is moving by so fast already. We have noticed an increase in people still scanning in with barcodes in their hands. Barcodes should be placed on your vehicles, not taken from vehicle to vehicle. If you have more than one vehicle you need to register each vehicle so it has its own barcode sticker. Rules are put in place for a reason. This stands for existing and new residents. Please make sure the POA office has all of your updated information on file.

When entering the com-

munity at the Main Entrance off of 109th Avenue through the resident's side on the right, please make a complete stop at the stop sign, wait for the vehicle in front of you to proceed through and the gate arm to come down completely. Once the gate arm comes down completely you may proceed by the barcode reader and make sure the gate arm goes up before entering the community. If you are entering through the left side at the Main Entrance, you must stop completely and check in with the gate attendant, even if you have a current barcode on your vehicle. The

attendant does not know that the only reason you entered that lane is because you did not want to wait in the resident's lane. The gate attendant might think that your barcode is deactivated for non-payment of dues or other fees or maybe the vehicle was sold to a non-resident and they didn't remove the barcode. Once you give them your name and address they will open the gate arm for you. If there is a vehicle in front of you do not proceed until after they have entered the community, and the gate arm comes down completely. Once that happens the gate

attendant will open the gate arm for you. You must also yield to the vehicle in the right lane. Also, please be respectful and patient with gate attendants when entering the community. They are only doing their job. Pet owners, while you are out with your pets, make sure they are on a leash. Those that let them out in the yard alone, if you know your pet is an escape artist, make sure that you keep them from escaping and running amok throughout the neighborhood. Also, it is too cold for some to sit out for long periods at a time, set a quick

timer so you don't forget to bring them back in. Resident's, please check on your elderly neighbors. If need be, call the security office and ask us to do a well-being check if you no-

tice a decrease in their usual daily routines. Thank you all for your continued support. Please keep us abreast of any suspicious activities and let's continue to keep the Lake of The Four Seasons a great place! Have a wonderful month.

# The Indiana Territory was a vast area prior to statehood

The Treaty of Paris, signed on September 3, 1783, by representatives of King George III of Great Britain and those of the United States, officially ended the American Revolutionary War. As a term of settlement, Great Britain ceded all of its land holdings west of Pennsylvania, north of the Ohio River, west to the Mississippi River, and north to the border with the British lands in Canada.

The Ordinance of 1787 was enacted on July 13, 1787 by Congress. It created the Northwest Territory, the new nation's first organized unincorporated territory, which included the future states of Indiana, Illinois, Michigan, Ohio, Wisconsin, and a part of Minnesota. The ordinance established the precedent where the federal government would be sovereign and expand westward, with the admission of new states, rather than the expansion of existing states. It also prohibited slavery in the territory.

On May 7, 1800, The US Congress decided to split the Northwest Territory into two parts. The larger portion was known as the Indiana Territory. It extended westward to the Mississippi River and from the Ohio River to the southern boundary of Canada, comprising all of the states of the Northwest Territory, except for Ohio. William Henry Harrison was appointed by President John Adams as the first governor of the Indiana Territory. Vincennes, the oldest settlement of the territory, was made the first capital, and the site of the first newspaper, the Indiana Gazette. In 1800, the territory's white population numbered about 5,600, of whom about half lived along the Ohio River or in the Vincennes area.

The federal government had responded to the three major obstacles to settlements in the new territory—Indians, land policy, and local government. The record was mixed. However, success included a reduction in the Indian threat, an efficient workable land policy,

and a gradual movement to a government that allowed increased democracy and local control.

By 1810, when the Indiana Territory had been considerably reduced in area by the splitting off and creation of the Michigan (1805) and Illinois (1809) territories, Indiana had 24,520 residents. Considering the reduced size of the territory and increased population growth in southern Indiana, the capital was moved to Corydon in Harrison County in 1813. Thomas Posey was appointed by President James Madison as the new governor of the Indiana Territory.

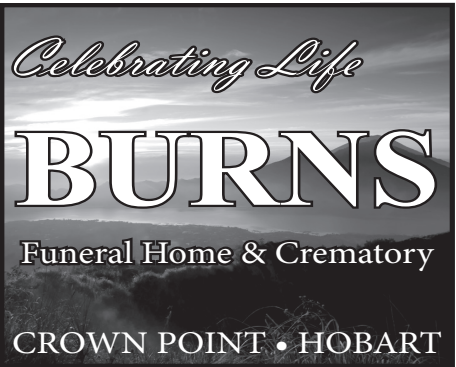
In 1815, the Indiana statehood petition was submitted to Congress. In the following year after much debate and deliberation, Indiana became the 19th state of the United States on December 11, 1816. Corydon was designated as the capital of the state, where it remained until 1825, when the seat of state government was moved to Indianapolis, a new planned community near the center of the state.
