tions on the same day to the POA office, and documentation verified as complete and valid.


• Monday, August 3 – Candidates Night issues forum at 7:30 p.m. in the LOFS Seasons Lakehouse ballroom.



As we drive around the community, we see so many people mostly teens - riding around in their cars together, walking side-by-side down the roads, or grouping together at their homes chatting. While we know in some cases, they are family or people living in the same home, there are more instances where this is not the fact.

I would ask parents to remind and, in some case, reeducate their children that no one is immune from the current virus plaguing the world. Also let them know that even when you're not at home that they should follow the guidelines that have been put in place for their safety as well as yours.

I hope all of our residents are well and doing fine and have adjusted to the coronavirus quarantine. It looks like a lot of the families have been staying home and cleaning up their yards by the number of leaves that we collected this Spring. If you are still doing some cleaning and want to dispose of the leaves you can bring them to the Maintenance facility and put them in the leaf pile located at the South end of our facility.

We are now out chipping branches. We will be in Lake County until May 4. To make

sure that your branches are collected, you must have them out to the edge of the street no later than May 3. After May 3 you can bring branches to the maintenance facility. On May 11 we will start Porter County and continue until May 18. Branches must be at the street no later than May 17 to be assured of a pickup.

If you are a Dog Park member you will notice a few new accessories that were added for your dog's enjoyment. We added a 'Top Dog A-Frame Ramp'. This lets them run up one side and down the other. There is also an adjustable bar jump

for them to jump over at different heights. We have installed each of these on both sides of the park. We hope they will enjoy them. When coming to the dog park remember we do have to do maintenance from time to time. We try to accommodate the members as much as we can, but if we are doing maintenance please use the side that we are not on.

Even though the playgrounds have been closed down, the parks are still open and have to be kept up. We are out every week cutting over 250 acres of grass, which includes parks, ballfields and miscellaneous green space areas. If you see one of our mowing crews please be careful when passing them.

This stormwater runoff also carries large amounts of pollutants directly into our lakes. Pollutants such as oil & grease from our roadways, pesticides & fertilizers from our lawns, sediment from construction sites and discarded trash and litter. There will be no stopping at a water treatment plant, this stormwater and all the pollution it can carry goes directly into our lakes and beyond into the waterways of the U.S. If uncontrolled water pol-

lution will continue to grow, our lakes will not only look and smell bad, but will hinder our boating, fishing, and swimming. Eventually our groundwater will not even be fit to drink.

An example would be the Cuyahoga River just 50 years ago. Running just south of Cleveland, Ohio, the Cuyahoga River became so polluted with trash, scum, and petroleum products it became flammable. It caught fire and burned nine different times between 1868 and 1969. Of course, we do not expect to see flames on Lake Holiday any time soon. But we can see other changes the lake is going through. Algae is increasing in the lake, noticeable by the watercolor's increasing green tint. Or by the scummy, smelly algae blooms caused by the Blue Green Algae (cyanobacteria) that forms in the lakes. The algae are caused by the polluting of the lake water by yard fertilizers, leaves, lawn clippings, and animal waste.

Groundwater contamination from petroleum products, pesticides, household chemicals leaching into our groundwater, over time can cause serious health problems. If these toxins enter our well water supply, our drinking water may someday become too poisonous to drink. Causing certain types of cancer through long term exposure. It has happened elsewhere it could happen here.

To enjoy and maintain quality fresh water for fishing, swimming, boating, and drinking, clean stormwater (coming from rainwater, snow melt, sump pumps, landscape irrigation, and a few other areas) should be the only water to enter our water bodies. Anything, else entering the system is usually considered an *illicit discharge*. **Illicit Discharge Detection** 

& Elimination (IDDE) The primary duty of the

Municipal Separate Storm Sewer System (MS4) Department is to help protect all waterways of the U.S., which includes the Lakes of the Four Seasons, from being polluted. Because stormwater runoff is generated from almost everywhere, efforts to prevent stormwater pollution must include all people of the U.S.

Through public education and outreach the MS4 involves the residents of the community to help prevent our stormwater from being polluted.

Residential pollution prevention includes household control measures that target the following areas. · Yard and lawn care



# Gardens Around the Community: Vegetable gardening is easy

Vegetable gardening is as easy as picking a spot in your existing landscape and planting. This is one of the easiest methods. It also allows you to see if growing your own food is something you like to do.

One of the best crops of bell peppers I had were planted on the east side of my house. I had actually planted them, tended to them ever so carefully, and then forgot about them (on accident of course). I had peppers aplenty that year. Tomatoes planted on the south side of the house have done incredibly well too.

Don't have space in your landscape, how about growing your vegetables in pots? Just make sure the pot you choose will allow your plant to reach its maximum growth. It should also have drainage holes to allow excess water to escape. Use a soil that works

best for growing vegetables in pots. Your local gardening center will be happy to help vou.

A quick google search recommends a pot 18-24" for a single tomato plant. 18" if the plant is determinate and 24" if it is indeterminate. Determinate is a bush growing tomato. The growth is compact and the fruits stop growing when set on top bud. Indeterminate will continue to grow and produce fruit until killed by frost. Pepper plants need a pot 10-12" deep and wide. Usually three plants per pot is good.

A raised garden bed can be done using untreated wood, large rocks, or just about anything you could use to create a raised border around your garden. Avoid using treated wood because the chemicals can leach into the food you will be eating. Be sure to use

raised bed gardening soil. Other soils will be too compact and not allow root growth. If you have the time and the resources, you can research how to make your own raised bed vegetable garden soil mix.

Your growing vegetables will need an inch of water per week. Water at ground level not from above to prevent disease from growing.


Remember to have fun

A helpful hint, flower and vegetable seeds last longer than the expiration date on the package if they've been stored in a cool, dry place.

# Solon Robinson was an early settler of Lake County, founder of Crown Point

LOFS probably have never heard of Solon Robinson, except for some Lake County residents who recognize the name as a grade school in Crown Point. Who was this man and what is his historical significance? Let's find out.

Solon Robinson was one of the first men in 1834 to settle in what became Lake County, and he is considered to be the founder of Crown Point. His influence and efforts had a positive effect on the history of the county and of Crown Point.

Robinson was born in Tolland, Connecticut on October 21, 1803, the son of Jacob, a cooper by trade, whose grandfather James was a Puritan, who had come over with the Pilgrims. Jacob married Salinda Ladd and in their family Solon was the fourth son. When Jacob died early, Mrs. Robinson, incapable of caring for the large family, put her children in the care of others. Young Solon had a natural instinct for farming, then he apprenticed

himself out as a carpenter, but ultimately setting himself up as a peddler.

In 1830, Solon married Miss Mariah Evans of Philadelphia, a woman of gracious and good qualities. They shortly moved to Jennings County, Indiana, about 20 miles southeast of present day Columbus, and two children were born there. In October 1834, Solon and his family settled in Northwest Indiana, in a place that came to be first known as Robinson's Prairie, then Lake Courthouse, where additional children were born. His wanderlust and pioneering spirit may have prompted his move to this area.

Solon Robinson's early records of achievements are interesting and varied. Together with his brother Milo (the first of the settlers to die), he opened a store and traded with both Indians and white men. His cabin was a simple log affair, which stood just northwest of the presentday square, and a marker (see photo) denotes its location.

He built Lake County's first courthouse, using his own money, dedicated its use for court, school, church, elections, Sunday school, and temperance meetings. In

1836, when the territory came to be Lake County was separated from Porter County and divided into three townships, Solon became justice of the peace for Center Township. He was also the town's first postmaster, and he renamed the town Crown Point. He owned the first printing press in the county and started the region's first newspaper,

Robinson apparently felt a need to express himself, as he wrote a series of agricultural articles for several newspapers. His contributions to the New York Tribune so impressed its owner Horace Greeley that Solon became its agriculture editor. He also originated the National Agricultural Society in 1841 in Washington DC and established branches in many states.

Because Mrs. Robinson did not share his desire to go to New York, Solon made frequent trips there, ultimately leaving Crown Point permanently in 1852, leaving his property in his wife's care. During his association with the Tribune, he maintained a farm in Yonkers where his experiments in grafting, fertilizing, and propagating drew material for his writings, which were from 1852

#### to 1870. After Mariah's death in

1872, Solon married his longtime personal secretary, and the last years of his life were spent in Jacksonville, Florida, where he went for health reasons. He died there in 1880, and he laid in peace until a group of Crown Point citizens became interested in the man whose name was given to the school.

After considerable research, it was determined Solon was buried in Florida,

and a search of his relatives led to an agreement to have his body disinterred and moved to the Crown Point Maplewood Historical Cemetery. In 1993, he was reburied within sight of the school named after him.

He was Vice President of the Highland Chamber of Commerce and Realtor of the year in 1980 before he retired. A member of Holy Spirit Catholic Church, Bob loved music and spent much his free time singing in a quartet and with the Chorus of The Dunes, playing the trombone with the Rusty Pipes and German Band. You never knew when he would pull out his harmonica and play a tune or sing while playing his player piano. He brought many a smile to doctors, nurses and people in waiting rooms playing the harmonica. He also loved spending time

with his family, supporting his kids, grandkids, and great grandkids sporting events, concerts, plays and going camping, boating, fishing, skiing, vacationing in Twig, MN and always time for a family hootenanny. Bob is Preceded in death by his parents, Leanore & Ernest Ellingsen. He is survived by his loving wife of 67 years Dolores F. Ellingsen (Mirth), 6 children Robert (Sue) Ellingsen, Nancy Ellingsen, Don (Theresa) Ellingsen, Janet (Jerry) Key, Cheryl (Bob) Golec, Dave (Melissa) Ellingsen, 22 grandchildren, 24 great grandchildren, and sister Betty Murray.
