

It has been difficult the last few years to say the least, trying to keep everything together as it has been a challenge to find and retain employees, especially for both restaurants and the Security Department, and attempting to stay within budget as the cost of everything has increased.

residents through the POA Office. The office staff prepares documents for the sale of properties. They calculate the sales of all amenity purchases such as stickers for vehicles, boats, golf carts, and dog park tags.

The office staff also calculates, processes and files every invoice for each purchase that is made by each department. They answer countless numbers of phone calls. They are always willing to answer questions or find answers for you. We continue to work with the POA attorneys on the collection of delinquent dues and other important POA matters. We closed the office to the public again during this

past dues season. The POA office staff can accept more payments for dues and amenities by phone, email, and the website instead of people congregating in the hallway at the POA office and talking over one another.

The Operations Building Maintenance departments continue maintaining the POA buildings and structures throughout the community, which includes the pavilions, bath houses, restaurants, and the pool house. They also maintained several acres of parks and green space areas throughout the season, which included mowing, trimming, drainage, planting grass, and preparing and cleaning up for the concerts and events. Soon they will be in the process of winterizing the buildings, leaf collections, and snow plowing. They do a great job.

The 19th Hole and Seasons Lakehouse had their struggles this year. The major challenge is not being able to find and retain employees. Food and liquor costs have increased and unfortunately that has to be passed through to the patron. We began using bouncers at the 19th Hole after the concerts this year and turned away people trying to use fake id's, and removed people that were causing problems. That worked out very well for the servers and bartenders. The concerts went very well this summer. The weather was incredible.

The Security Department continues with their day-today duties of checking in guests, patrolling the community, answering calls 24/7, responding to emergencies and repairing gate arms.

Several people ignored the signs when entering or didn't listen to the gate attendant before proceeding through the entrances and damaged the gate arms and gate arm controllers. This added unnecessary work for the staff.

Our new Security Director Fred Scott has had his fair share of issues with finding and retaining employees this year too. He put in several hours and is doing his best to keep the department operating. Fortunately, he was able to hire a few officers and a couple of dispatchers within the last couple of weeks.

During the next few months, the Department Managers, Board Directors, and I will be working on the budget for the 2023-24 season. This is a large undertaking to complete and all of us will be putting in a lot of time receiving

I would like to thank the committee members Terry Miranda, Keenan, Ray Building Inspector, Kurt Whitehead; also the Security Department and the Community Manager.





The entire staff at the Lakehouse has gone above and beyond when it comes to both the restaurant and banquets. I am beyond proud of them and appreciate all the hard work they put in. They truly work together as a team and I could not be more thankful for them.

I believe that there is always room for growth and knowledge, and I will continue to educate myself and my staff to ensure we continue to provide a memorable experience for each and every guest we take care of.

Lakes Department Annual Report

The Lakes Department had a great year; we accomplished many of our goals. Lake Patrol did a great job assisting boaters and helping the lakes stay safe and enjoyable for everyone throughout the year.

Big Bass Beach storm drainage was fixed and is now draining properly. There is no more sand washouts or flooded areas around the beach.

This past spring, we used the electrofishing boat to remove shad and carp from Lake Holiday and Big Bass Lake. We will continue to remove these nuisance fish in the spring and fall.

There have been more green flags on all the lakes this year compared to years

past. Over the past few years, we implemented a plan to let some of the native rooted vegetation grow and act as a filter to combat the excessive blue/green algae blooms we have been getting. Along with the bacteria/water conditioner treatment plan for these lakes, this has all been working. The algae blooms we get are minimal and more controllable. We will continue to manage the vegetation accordingly and hopefully this trend continues.

We added six (6) new aerator diffusers to Lake

Holiday on the south side down the middle of the lake, and replaced six (6) old diffuser heads. All the aerator compressor boxes have been replaced this year on Lake Holiday and with proper maintenance, these should last ten-plus years. Next year, we will be adding eight (8) new diffusers to the north end of Lake Holiday.

Lake on the Green had a fish kill in July caused by a weather event. We will be conducting an electrofishing survey in the next few weeks out there to determine what will need to be stocked this coming spring. We are also looking into some options to prevent this from happening in the future that will be discussed with the new Board of Directors at the upcoming budget meetings.

I would like to thank Rick Cleveland for his help and guidance throughout the year and the current Board of Directors for giving the Lakes Department the funds to move in the right direction. I would also like to thank Tim Rachoy and Blake Bardeson for their time and dedication to the community over the past few years. I look forward to working with the oncoming board members and making more improvements to the lakes next year.

Master Plan Committee Annual Report

In 2018, the LOFS POA commissioned the Arsh Group (Architectural and Land-use Planning firm, Merrillville, Indiana) to develop a master plan for the neighborhood. The process involved a steering committee of LOFS residents along with LOFS Board members and administrators. The process also involved an extensive survey that was sent out to all property owners. The data was collected and then priorities were arranged so the current and future Board members could utilize this document as a tool for both short- and long-term improvements to the neighborhood. The finalized plan was presented on September 5, 018.

In February 2021, the LOFS POA Board of Directors requested volunteers (via an advertisement in the monthly Seasonal) within the neighborhood to serve on a Master Plan Committee that would continue the effort and vision that was started by the Arsh Plan. The POA Board of Directors reviewed all interested candidates and selected the following POA members to serve on the Committee:

All of the Master Plan

Committee members listed above were reappointed at the 2021 Annual Meeting.

The Committee met on October 20, 2021; November 17, 2021; December 15, 2021; January 19, 2022; March 23, 2022; June 8, 2022; and October 3, 2022. The LOFS Master Plan Committee also presented the proposed southwest land development project at a (Public) LOFS Special Meeting on April 11, 2022.

The charge of the committee was to set goals and priorities for potential neighborhood improvements that would continue to make LOFS a premier neighborhood within Northwest Indiana. The Committee decided to focus on both short-term and long-term priorities that could be strategically implemented based on current and potential funding.

2021-2022 Update

 Southwest Vacant Lot Development: The Master Plan Committee recommended that the LOFS Board proceed with the initial contract for developing the southwest vacant lot that is owned by LOFS. The initial contract would include engineering and due diligence by the developer at no cost to LOFS, however, it would determine if this proposed development is feasible given the known and unknown constraints of the property relative to utilities and municipal guidelines. The Master Plan Committee also developed a draft set of development guidelines that could be utilized in addition to the existing building development standards contained in the current LOFS covenants. The Committee also would be involved in reviewing the proposed engineering documents of the development to ensure the

intended quality is realized prior to construction.

- Dam C Improved Path:
 The LOFS Master Plan
 Committee recommended
 that the LOFS Board include
 engineering services and a
 feasibility assessment for implementing an adequate east/
 west improved path at the
 south end of Lake Holiday
 on Dam C. Funding for this
 study was included in the

- 501c3 The Master Plan Committee is currently pursuing a 501c3 designation so funds may be raised to provide additional support to the presented priorities.

Assuming that all current committee members are retained, there will be one vacancy after the October 8, 2022 annual meeting. Anthony Mansch will resign his position on the committee as he transitions to an elected position of the LOFS Board of Directors.



Last winter dead trees were removed from several locations on the golf course. The stumps were ground, and the areas have been seeded. Several drainage ditches have been cleaned out allowing the water to flow properly. The biggest improvement was the trees and scrub bushes that we removed from behind the number nine tee.

This spring several new trees have been planted in various locations on the golf course. The area that received the most attention was the driving range and Pro Shop area. The new driving range mats and clock tower have really improved the practice facility and the aesthetics of the entire area. The additional landscaping around the clock tower is beautiful.

The entire Pro Shop area was a stop on the Lake County Masters Gardeners tour. Kim, Timberly, and Helen continue to do an amazing job with the flower beds on the golf course and in the community. We are lucky to have them.

This summer, like most summers, the focus is to give the golfers the best playing conditions possible. The greens, tees, and fairways

have held out well especially with the amount of play and cart traffic on a daily basis. This is the second year with the new electronics in the irrigation system and it continues to be a huge success. The only project this season was the completion of the new ladies' tees on holes six and eleven. Both tees are filling in well and will be ready for the 2023 golf season.

This fall/winter we are going to continue our bunker renovations when the leaves are done falling and the grass

slows down. The plan is to install the bunker liners in six bunkers. That will put us past the halfway point in the renovation process.

The 2022 golf season has been one of the most successful because of my amazing staff. The retired guys who not only did their jobs but are willing to help with whatever I asked them to do. The teenagers who worked this summer did a great job of maintaining the bunkers and keeping up with the trimming. Bob Lukas has done an amazing job the

entire season. I can't express how important Bob has been to the overall quality of the golf course.

Thank you to Rick Cleveland, MGA, WGA, and the POA Board for their continued support. Gina and Fara at the 19th Hole have been a pleasure to work with this season.

Golf Services Annual Report

2022 was another great year for our golfing community, started a little slow with not-so-great weather in March and April, but after that is was perfect. Our success starts with my wonderful staff, my assistants Joe and Finn, my inside staff Stephania and Elizabeth, my rangers Jim, John and Zach and to my outside staff Jack, Noah, Sarah, Gavin and Hayden a huge 'THANK YOU'. I'm very blessed to have you all as my employees but also great employees to this beautiful community.

Memberships

The golfing community continues to grow, our membership hit a new record with a total of 419 members, which is a combination of 387 adult members and 32 junior members. Last year we took in \$331,968 in membership fees compared to \$358,218, which is an 8% or a \$26,250 increase.

Green Fee and Driving Range

The game of golf continues to grow, which is a big part of our success. Green fees as of the end of August is up \$2,000 compared to 2021 and September was a very good month. I'm seeing more members and residents bring out more guest (nonresidents) to this beautiful course. The driving range has increased tremendously with the help of our Player Development Programs and the Boost Golf Academy, golfers of all skill levels love to practice, our range is up 12% compared to last year at this time, end of August.

Not only is the driving range busy, but our practice putting green and our practice chipping area (bunker area) was very busy.

Player Development Programs

As the head of the Player Development Programs, we increased all aspect of the Academy compared to last year. We started with the Bootcamp 101, which these future golfers really had no idea or a little on anything with golf for example where to go for range balls, drive a golf cart, the 19th Hole for food and beverages, anything with golf.

This 4-hour program taught them all of that plus lessons on the swing, chipping, putting, and course etiquette and have a great time. We had a total 14 future golfers compared to 9 last year.

Then there is Boost Golf Academy for Ladies and Juniors, which is a 4-week program with two lessons

per week. We had three semesters this year and for each one I taught the game on how to play thru drills and instruction, also taught sportsmanship, and lastly and most importantly, have fun with this great game. We had a total of 31 Ladies compared to 24 last year and we had 33 Juniors compared to 22 last year.

Then we had our future 36er's program for our youngsters aged 3-6, which is a 4-week program. It introduces them to putting, chipping, and the swing thru fun drills and excitement. We did this three times this year and we had a total 23 future pros compared to 14 last year.

Then we end it with our Junior Golf Academy, which is 8-week program on Tuesdays, and we had a very impressive 75 juniors participate. They learned all aspects of the game and once they received instruction, they either

played 2 holes, 4, 6 or 9 to see if they pass to the next level. On our final day we crowned the winners of The Johnny Classic, the hard worker of the year award, then the prizes, pizza party and our massive water balloon battle where Joe, Finn and I got the worst of it AGAIN. Next year I have to call the LOFS Fire Department's truck for backup!

Merchandise

This has been a huge year of merchandise sales for us so far and we expect to finish strong. As of the end of August, my budget for sales was \$140,000 and in six months we did \$139,101, which is \$40,783 more than last year at this time. I brought in more different companies from clothing, clubs, balls, bags, shoes, shorts, skorts, dresses, and more.

I saw an opportunity for our community with Ringo's closing, so we opened the

Golf Shop to the public (not the course) with advertising in Golf Plus and word of mouth. I really see next year to be even bigger.

Final Note

I would like to give a huge thanks to the Women's Golf Association and the Men's Golf Association for their continued support to our operation, the golf course, and the golf community. Both organizations' relationships have been so great to our goals and vision of what we want to accomplish. It has been a pleasure working with all the outgoing Board Members and looking forward to the newly elected ones.

One last final note, I want to thank the LOFS Community, its residents, the golfing community, Rick Cleveland and especially the POA Board of Directors for giving me the opportunity to serve this great community as your PGA Professional.

dream cities near Lake Michigan **Early promotors planned several**

Pluchinsky, LOFS Historical Society



While the early pioneers in our area were building their log houses and creating farms, another form of activity was taking place along the southern shore of Lake Michigan. Speculators were busy planning harbors and cities which they hoped would surpass in importance Michigan City and the bustling young town of Chicago.

In 1837, several foresighted men laid out a town which they called City West. It was located on both sides of the small stream called Fort Creek that flowed into

Lake Michigan in what is now the Indiana Dunes State Park. They also built a hotel, the 'Exchange', with 22 rooms, and it had the largest tavern in the area. A sawmill, blacksmith shop, and a store were built, and about 20 families established homes in the new town. The promoters also planned to build a canal, to be known as the Lake Michigan and Kankakee Canal, which would tie into Salt Creek. Long range plans also included building a railroad from City West to the Kankakee River.

The greatest day in the brief life of City West was July 1, 1837, when Daniel Webster visited the town

during a tour of the west. The senator and family were making a leisurely voyage on a lake steamboat from Chicago to Buffalo. Eager for a Congressional appropriation to build their harbor, the promoters of the town lavishly entertained the senator. However, due to prior agreements, nearby Michigan City was given the initial appropriation for a harbor.

Failure to get Federal aid for a harbor brought an end to the plans for the city at Fort Creek. By the end of 1838, all the inhabitants had moved away. Some of the buildings were moved, and those that remained were destroyed by fire several years later.

Meanwhile, the town of Manchester was being planned and platted just west of the mouth of Salt Creek, near the present Bass Pro Shops complex off Route 249 in Portage. Since a branch of the Chicago-Detroit Road crossed the nearby Little Calumet River, a navigable stream, the place was considered an excellent site for a city. As previously mentioned, a canal was planned to provide access to Lake Michigan at City West. A few lots were sold, but later the remainder of the site was auctioned off to satisfy a mortgage on the property.

The promoters of Manchester most likely were only interested in making a quick dollar from gullible investors.

Also in 1837, the town of Indiana City was laid out on the lakefront just west of the old mouth of the Grand Calumet River, now in Gary's Marquette Park. The place was apparently a 'paper city' as no records have been found that any lots were sold or that it ever had houses or inhabitants.

Waverly, another early region town, was founded in 1834 on a site about two miles northwest of the present Chesterton. There, John Foster began what he hoped town. Valuable improvements were made only to be destroyed in 1939 by a forest fire. Present Waverly Beach is named for the Waverly Road, which passed through the town site on its way to the lakeshore, is the only reminder today of Foster's dream in those early years.

Although some historians feel the failure of these 'dream cities' was caused by the Panic of 1837, it remains significant that the only cities to survive and prosper in this period were Chicago and Michigan City. These were the ones that received Federal aid for the development of their harbors.

Starting last fall with helping Bruce and Jill Nix putting up the Christmas display on the front lawn of the Lakehouse for the tenth year. Thank you two for all the work you do to make the Holidays more enjoyable in Lakes of the Four Seasons.

Last year was our initial set up for the Christmas on the Lake event. All went pretty smoothly with lighting trees and decorating all different areas of the Lakehouse. There was a pretty good turnout; matter of fact a lot of the residents said that it was the largest turnout they have seen in years for any event and this year is on its way to being even bigger. We have added more electricity to the tennis courts, installed a new walkway from the parking lot to the tennis courts and extended the sidewalk from the pool to the tennis courts. We are also going to decorate the front gate, the 19th Hole and both of the side entrances.

While setting up for Christmas we also have our normal duties to perform, like leaf collection which will go until mid-December, garbage pickup which is all year long. Then into fall. We have now finished branch collections for the year. If anyone still has any branches they want to dispose of they can bring them to the maintenance yard. The Maintenance Department worked short-handed for this year and we were still able to keep the Seasons looking good, neat, and clean. I would like to thank my crew for all the hard work and long hours that they put in to make my job a little easier.

I would like to thank this year's board for putting their trust in me to do this job and giving me the tools to do it. I would like to thank Blake and Tim for volunteering their time to do this job.
