
BLUETOPRIDG Matthew Meneghetti (aka Ghetti) started his golf ca-



September has arrived. The summer concerts are in the rear-view mirror. Many of our young people have left for college, making it a little quieter around the house, and the little ones are back in school. Let's do our best to keep them safe as they are standing outside waiting for their buses.

As a reminder to residents who are using their homes for rental property, it is required that you register your renters with the POA office. It is a covenant violation if you fail to register your renters. There are times, especially in an emergency situation, when Security needs to contact subjects living at a residence

and there is no information. It is important that Security has the information available to them, including phone numbers, of the occupants of all residences.

Another reminder, all subjects signing into the community must provide the address of their destination. It is also required that anyone driving on Lakes of the Four Seasons roads must have a current, valid driver's license. If you are expecting someone at your residence to do work and they are turned away at the gate it is most likely they do not have a driver's license.

Security is requesting that all golf carts coming through the front gate use the sign-

in lane. The dispatchers will open the gate for you, but you must wait until the gate comes down behind the vehicle in front of you before you proceed. If you try to follow a vehicle, the gate WILL come down on your golf cart.

Also, be sure to have a current decal on the front windshield. All expired decals must be removed. Parents, be sure you have seatbelts when you have children on the golf cart. Also, do not hold a child on your lap. It would be a tragedy to have a child slip off a golf cart and get injured. Let's set a safety example for our children!

To maintain aesthetic quality, and resident safety within the Lakes of the Four Seasons (LOFS), policies have been put in place by the POA. All homeowners when moving into the LOFS, have agreed to abide by these policies. I have found it necessary to post a couple of these policies.

Limbs And Branches

The LOFS has set dates twice a year to pick up limbs and branches left at the street. For year 2022, Spring collection dates have passed.

Fall branch collections, for the Lake County side of the Community will begin on September 6 and continue until the final date of September 14.

Fall branch collections for the Porter County side of the community including all of Brandywine Road, Beachview Court, Sandy Beach Drive & all of Forest Lane will begin on September 19th and continue until the final date of September 28.

During non-pickup days branches may be taken to the LOFS Operations facility located at 3861 Kingsway Drive. Hours are 6:30 a.m. to 3:30 p.m. Monday through Friday. Hours on Saturdays are from 8 a.m. until noon. Exception to these rules are limbs brought down by heavy winds. These limbs and branches may be

placed at the street. Call the Operations Department at 219-988-4461 to have these limbs picked up.

For the safety of all, homes in the community must have an address clearly posted on the front of the residence or on a fixed object within feet of the residence. Homes on a lake must also post their lot number on a dock or a fixed object within 10 feet of the shoreline. Both front and lake side numbers must be clearly visible to emergency personnel, and POA personnel. These numbers are for you and your family's safety or for the safety of some who may be injured at or near your home. Numbers must be at least 4 inches in height and in a contrasting color from their background. Beige on white or black on brown

are not contrasting. Black on white or white on brown are contrasting. Remember these numbers can mean time to an injured person who may need every second.



Old newspaper clippings tell about LOF's early planning

ticles detailed highlights from old newspaper clippings from 1966 about the planning of The Four Seasons, and this article concludes the series.

Datelined Crown Point, subsequent newspaа per article is titled "Gets Preliminary Lake Plan OK." The article continues, "A planned community intended to bring some 9,000 persons into a 'private town' straddling the Lake-Porter line east of Crown Point won first approval Monday night. The Lake County Plan Commission granted preliminary approval to the

proposed 'Lakes of the Four Seasons' residential-recreational subdivision and voted to recommend what amounts to a rezoning of 60 percent of the 1,800 acre site."

Continuing, "The Porter County Plan Commission will consider the proposal Wednesday night. Commissioners here have 60 days to conform or reject the community unit project rezoning for more than 1,000 acres under their jurisdiction. Company spokesmen call it a 'private, self-regulating community', with its own utility plants, street maintenance and snow removal equipment, traffic patrol and park system. The settlement's 'interior government' would be run by a board of directors

elected from members of the property association created by deed covenants."

"Each lot owner would become a member of the association when he purchased his property, would have a vote in the local 'government' and would be assessed an annual tax-hike payment-pegged at around \$20 by the developers to help finance the operation."

"The community would include a boating dock, a fishing lake, a series of ponds, two golf courses, a clubhouse and a shopping center. Ownership in the subdivision would bestow membership in all of its facilities under rules calculated to exclude what the developers call 'undesirable' persons."

plans about the schools. about changes to main streets to be 24 ft. wide and feeder streets would remain at 20 ft. Plan members were distressed at the complete lack of sidewalks but voted the approval without them. A Lake County commissioner expressed concerns over possible mis-management of the community's internal affairs under the "private government, assessment-financed" system.

"Spokesmen for the developers said they needed the plan commission approvals here Monday so they can 'open' the subdivision by July or August. They must start immediately with the first stages of sewer installa-

The article continues with tion, water line construction, dam building for the lakes, and construction of the golf courses and clubhouse facilities. They indicated the multi-million dollar project will be developed in stages, pegging ultimate completion of the last homes some 20 years into the future."

"U.S. Land, Inc., will not build any of the planned 1,346 single-family houses, 180 'condominium' dwellings or 220 apartment units. The development firm is merely the sub-divider and lot-sales agency, according to James Letsinger, local lawyer for the company".

So we conclude the reviews of some old newspaper articles about the development of The Four Seasons.

Our community has prospered over the years, thanks to the elaborate early planning. As a matter of information, construction of LOFS began in the summer of 1966. On October 12, 1967, Tony and Betty Lazar and two children moved into the first house built here, on Lot P-28 (1361 Brandywine).

In 2016, the Four Seasons celebrated its 50th Anniversary with a series of events. At that time, a very elaborate anniversary book was published that included our history, individual personal stories, and other information. Copies are still available from our Historical Society.

As we are now in the heart of our season with events and leagues, I want to remind the community about the USE OF THE GOLF CART PATHS FOR NON-GOLFING PURPOSES.

Using the golf course path for anything but a registered and paid-for round of golf is prohibited. Specifically, the paved cart path at the front gate that passes around the back of hole #17 is a public path, however all carts must exit onto the road once reaching the front gate; continuing to travel onto the golf courses 18th hole is not allowed and tickets will be issued for trespassing on golf course property. Fishing on golf course property is also prohibited!

These rules are in place for both safety to residents and for preventing interruptions to golfers. Golf course Marshals and security will be cracking down on those that choose to ignore signs and continue to use the cart paths for running, jogging, biking, dog walking, or non-golf traffic with the issuance of fines at any time of day. 
