

CONSTITUTION

ARTICLE I NAME, OBJECT, AND PURPOSE

Name of this Association shall be **LAKES OF THE FOUR SEASONS WOMEN'S GOLF ASSOCIATION**. The object and purpose of this Association shall be to function as a non-profit organization, to foster interest of golf among women, to enjoy fellowship and friendly competition among its members, and to enhance the golf community at large.

ARTICLE II MEMBERSHIP, DUES, AND HANDICAPS

Membership of this Association shall be limited to Women Lakes of the Four Seasons Golf Club Members, who are 18 years of age or more. Membership shall be attained as stated in the By-Laws. Dues shall be determined by the Board of Directors and remitted according to the By-Laws. Handicaps are determined by Handicap Service. Procedures for procuring, maintaining, usage, and limits of handicap shall be as stated in By-Laws.

ARTICLE III MEETINGS

Meetings are scheduled by the Board of Directors as stated in the By-Laws.

ARTICLE IV GOVERNING BOARD

Control and management of Association affairs shall be entrusted to a governing body known as the Board of Directors, to be elected in manner provided in the By-Laws. Powers and duties shall be as stated in By-Laws.

ARTICLE V FINANCE, BUDGET, AND ADMINISTRATION

All phases of finance, budget, and administration shall be approved by the Board of Directors and procedures shall be followed according to By-Laws.

ARTICLE VI TOURNAMENTS, CLUB EVENTS, SPECIAL CLUB EVENTS

Tournaments, club events, special club events, and weekend events shall be approved and scheduled by the Board of Directors. Procedures shall be followed according to By-Laws.

ARTICLE VII AMENDMENTS

This Constitution may be amended at any regular meeting of the Association with one month prior written notification, by a 2/3 vote of the membership present.

ARTICLE VIII DATE

This Constitution shall be in effect from October 2017 and shall supersede previous 2014 Constitution.

BACKGROUND AND HISTORY

Lakes of the Four Seasons Golf course was open for 9 holes in 1966 and open for 18 holes in 1968. As golf play among women increased it was decided to form a Women's Association and an optional Thursday League, and in 1969 a Constitution and By-Laws were adopted.

BY-LAWS

ARTICLE I

NAME, OBJECT, AND PURPOSE

Section A
Section B

Women's Golf Association shall be hereinafter referred to as WGA.

Purpose and object:

- (1) WGA is a non-profit volunteer organization established and working to promote interest and friendly golf competition among women.
- (2) WGA entitles women who have a limited amount of time to devote to golf to become a member, establish a handicap, and thereby be eligible for club events.
- (3) Thursday League is an optional part of WGA. Members must first join WGA, then join Thursday League in order to be eligible for Thursday League prizes and awards.
 - a. Thursday League is divided between 9 and 18 Holvers.
 - b. Thursday League play begins the first Thursday in May and continues consecutive Thursdays until cut-off date in September.
 - c. Thursday League members may compete in all WGA events as well as Thursday League Events.

ARTICLE II

MEMBERSHIP, DUES, AND HANDICAP

Section A

Section B

Membership is limited to Lakes of the Four Seasons golf members in good standing.

(1) All Property Owners Association and Golf Club Dues are paid.

Dues and fees shall be determined by WGA Board of Directors.

- (1) Women desiring membership in WGA have two options. Members may elect to become:
 - a. A member of WGA by payment of yearly WGA dues and participation shall be limited to Golf Club events and stated events open to all WGA members.
 - b. Member may elect to become a member of WGA and Thursday Women's League by payment of WGA fee, plus yearly assessment of Thursday League dues.
- (2) Member shall elect for 9 or 18 hole play.
- (3) All dues and handicap fees are payable to the Treasurer prior to participation in events.
- (4) WGA dues and Thursday League fees shall remain the same for the entire year.
- (5) New members joining late in the season must pay a full year's fee.

Section C

Handicaps are determined by Handicap Service with proper procedures, maintenance, and limits of usage as follows:

- (1) All members are required to post their individual scores.
- (2) Handicaps shall be determined "established" when golfer has ten scores computerized and printed on handicap sheet; handicap card will then be issued to golfer in her name with handicap and scores printed thereon.
- (3) Only prior year members, both WGA and Thursday League, may use established handicap from previous year.
- (4) WGA and Thursday league members are not eligible to play in any event requiring handicap until all fees are paid.
- (5) Thursday League members electing to play 9 holes must play to a maximum USGA Index of 42. Thursday League members electing to play 18 holes must play to a maximum USGA Index of 42.
- (6) Thursday League member may change from 9 hole to 18 hole play providing the following qualifications are met:
 - a. "Established" 18 hole USGA Index is 42 or lower.
 - b. Decision to move up must be made by July 1.
- (7) Board of Directors has the right to suggest that 18 hole members move to 9 holes if maximum handicap is not maintained.
- (8) Nine hole league players may use the family tees and the handicap used for games only will be at the discretion of the 9 Hole Vice President and the golf pro.

ARTICLE III

MEETINGS

Section A

Meetings are scheduled by Board of Directors, April through September.

- (1) April meeting is open to all WGA members, and shall be to discuss forthcoming year's events.
- (2) Election of following year's Officers and recap of year's events shall occur at the final meeting.
- (3) Thursday League monthly meetings including 9 & 18 holes are open to all WGA members.
- (4) Board of Directors has right to call extra meetings if deemed necessary.
- (5) Board of Directors meetings shall be held monthly during the season.

ARTICLE IV

GOVERNING BOARD

Section A

Board of Directors shall be comprised of President, First Vice-President, two Second Vice-Presidents (9 and 18 hole Leagues), Secretary, Treasurer, Handicap Director, Rules Director, and Constitution Director.

- (1) Above offices shall be elected at September meeting, commence office on November 1, and shall hold office until following November 1.

- Section B Any member of WGA is eligible for any elected Board of Director's office.
There will be no term limits on any board position. However, each board member must be elected by a majority vote during a general election held each year in September.
- Section C Vacancies
The Board of Directors shall have the power to fill an elected office vacancy by majority vote and according to eligibility requirements (Section B, 1 & 2).
- Section D Power and Duties of Officers
- (1) President as elected head of the Association shall govern the Board of Directors, Chairmen, and members to work toward a successful season of golf.
 - a. President is responsible for calling and presiding at all meetings of the Board of Directors and the WGA. Board of Directors meetings shall be held once a month prior to regular meetings. Board of Directors meetings shall include appointed committee chairmen and special events chairmen at least twice a year.
 - b. President is ex-officio member of all committees except Nominating and Auditing Committees.
 - c. President is authorized to co-sign checks with Treasurer upon approval of the Board.
 - (2) First Vice-President is in charge of selecting social events, hospitality, and recruiting of new members.
 - a. First Vice-President is responsible for clearing and booking scheduled dates with Clubhouse Manager and Pro for WGA and Thursday events.
 - b. First Vice-President is responsible for sign-up sheets, publicity posters for golf club events and working with the Pro on weekend special events and tournaments.
 - c. First Vice-President is responsible for chairmen and special events appointed chairmen to fill in and return "Evaluation Reports".
 - d. First Vice-President shall preside in the absence of the President.
 - (3) Second Vice-Presidents shall be in charge of Thursday League golf events, both 9 & 18 holes, and shall determine event of the day, make pairings, starting times, and publicize golf events.
 - a. She shall determine weekly winners according to planned budget.
 - b. She is responsible for issuing weekly game prizes, including birdies and chip-ins, at Thursday League monthly meetings.
 - c. She shall be responsible (with Pro) for flighting, recording, and posting Thursday League Championship sheets.
 - d. 18 Hole Second Vice-President shall preside in the absence of the President and First Vice-President.

- e. 9 Hole Second Vice-President shall operate similar to 18 Hole Second Vice President. She shall be responsible for selecting 9 Hole Chairmen for Guest Day, 9 Hole ringer, and 9 Hold Special Events.
- (4) Secretary shall keep permanent record of Board of Directors, WGA, and Thursday League meetings in the minute book.
- a. She shall keep permanent records of all members (name, address, and phone numbers).
 - b. She is responsible for all correspondence.
 - c. Secretary is authorized to co-sign checks with Treasurer upon approval of the Board.
- (5) Treasurer shall collect all money due the Association, make monthly reports, and maintain the Association bank accounts.
- a. She shall record and post proposed yearly budget and updates approved by the Board of Directors.
 - b. She shall keep a ledger dividing money as follows: WGA Dues (all members); Thursday League Fees divided for 9 & 18 holes; Handicap Fees (all members); ringer Fees; Putt Money; Miscellaneous money derived from raffles, 50/50, donations, etc.
 - c. She shall be responsible for entering disbursements of funds in each category according to the above list.
 - d. She shall be responsible for balancing and maintaining all bank accounts and is authorized to co-sign checks and certificates with the President or Secretary upon approval of the Board.
 - e. She shall be responsible for monthly reports to the Association regarding income and expenses.
 - f. She shall be responsible for maintaining a file of all bills, invoices, and bank statements, etc., submitted to her.
 - g. At year's end, she is required to turn over all ledgers and pertinent files to the Auditing Committee.
- (6) Handicap Director shall work with the Pro on posting Handicap sheets and issuing Handicap cards.
- a. New Handicap sheets will be posted approximately every two weeks.
 - b. Handicap Director shall file second Handicap chart in Handicap book to be retained for one year.
 - c. She shall be responsible for keeping and posting up-to-date lists of members whose handicaps are not yet "Established" (see ARTICLE II, Section C, 3).
 - d. She shall be responsible for posting handicap rules and limits on Club Event Sign-up Sheets.
 - e. She shall check for eligibility to participate in WGA Club Events and Tournaments and validate handicap (see ARTICLE II, Section C, 1 & 2, and ARTICLE VI for specific events).
 - f. She shall be in charge of Match Play.

- (7) Rules Director shall be familiar with USGA Rules and be able to interpret same.
 - a. She shall work with Pro on local course rules and post changes before the Club Event or Tournament.
 - b. She shall keep members updated on any new course rules or USGA rules.
- (8) Constitution and By-Laws Director shall be responsible for reviewing and maintaining an up-to-date Constitution and By-Laws.
 - a. She shall be responsible for notifying the Board of Directors of any corrections, editing, and amendments her committee deems necessary.
 - b. She shall also be responsible for updating "Policies Section".

Section E

Special Appointment

First Vice-President, both Second Vice-Presidents, and Constitution and By-Laws Directors may be allowed to appoint an assistant with the Board of Directors approval.

- (1) Assistants cannot be a member of the Board of Directors and have no vote on the board.
- (2) Assistants are not entitled to attend Board of Directors meetings unless invited by the President.

Section F

Committee Chairmen: Shall be appointed by the President. The Committee Chairmen in turn shall choose as many members as they deem necessary to serve on their committee.

- (1) Publicity Chairman shall be responsible for submitting articles on WGA to be published in LOFS Seasonal or other newspapers. She shall maintain a yearbook with printed articles and any pertinent pictures taken of WGA events.
- (2) Trophy Chairman shall be responsible for purchasing trophies within budgeted amounts for all WGA events and Thursday League playoffs, to be presented at the October Awards Meeting. She and members of the Board shall determine winners of the following Trophies.
 - a. MOST IMPROVED TROPHY open to 9 & 18 hole members of WGA who have a previous year established handicap. Winner in each category shall be determined on basis of formula published by Golf Digest for Most Improved Player:
 - i. Beginning handicap multiplied by 2.
 - ii. Ending handicap multiplied by 3.
 - iii. Result a negative number.
 Award given to least negative number. In case of a tie Award will be given to the player with the lowest handicap. Dates to determine the winner of the trophy shall be taken from the first posted handicap in September of the previous season through the first posted handicap in September of the current season. (ie. Mary is a 15 handicap on first posted handicap in September 2001. On the first posted handicap in May

2002, Mary is a 17. On the first posted handicap in September 2002, Mary is a 14. Mary's beginning handicap is a 15 and her ending handicap is a 14).

- b. GRACE FOLEY AWARD. Open to 18 Hole members of Thursday League who have a previous year established handicap. Winner is golfer who has lowered her handicap the most strokes. In case of ties: Award to be given to the golfer with lower handicap. Dates to determine winner will be taken from the handicap posted on May 1 through the first posted handicap in September of the current season.
- (3) Ringer Chairman is responsible for explaining and setting up Ringer Charts. Ringers is a yearly contest for both 9 & 18 hole golfers. Ringers to begin on the first day of league play which is the first Thursday in May and end in the month of September. WGA member's name is entered on Ringer Sheets (9 & 18). Ringers shall be based on an individual's self-improvement on each hole, the beginning entry to be based on the lowest score on each hole after golfer's first three rounds of league golf. Prizes, by class, are awarded to golfer who improved the most strokes on each hole, and shall be determined by totaling differentials between the first posting (after 3 weeks of play) and last posting. Only scores on league Day will be used to determine ringers.
- a. 18 hole handicap players must play a full 18 holes to register ringer and 9 hole golfers must play a full 9 holes to register (front & back).
 - b. Ringer Chairman will enter all ringers based on scorecard turned in after league play which will have been signed and attested.
 - c. Ringer Chairman shall file and keep scorecard or ringer slips and shall file all subsequent slips turned in for verification.
 - d. The Chairman shall divide members into handicap classes at the beginning of the season.
 - e. Ringer Chairman shall determine payouts for each handicap class by number of players in each class. Payouts are determined by final handicap class. Players may move from one class to another. In case of ties, award will be given to the player with the HIGHER handicap. Payouts are based on total most improved score. Chairman shall determine number of payouts per class by rank and money in each class.

Section G

Special Chairmen and Committees

- (1) Nominating Committee appointed by the President, shall consist of a Chairman and four members at large (total of 5) and one member shall be a 9 hole golfer. Committee shall present a single slate of officers to be presented to the

membership at least one month prior to final yearly meeting at which time election of officers is held.

- a. Selections of Nominating Committee are limited by terms and eligibility requirements (See ARTICLE IV, Section B 1 & 2).
- (2) Auditing Committee appointed by Board of Directors shall consist of three members at large. The Committee is responsible for auditing the Treasurer's books and files and shall submit a written notice to the Board that the audit is complete by December 15.
- (3) Fundraising Committee, appointed by the Board, shall consist of Chair and four members at large.
 - a. The Committee shall act to raise funds for course and capital improvements and shall report to the Board annually with an accounting.
 - b. The Committee may choose to act in concert with the MGA for fundraising purposes.

ARTICLE V FINANCE, BUDGET, AND ADMINISTRATION

All finances budget and administration of the same shall be approved by the Board of Directors.

Section A

Income Revenue Funds shall be dispersed as follows:

- (1) General WGA club dues revenue shall be used for social and golf events and for trophies that involve the general association club.
- (2) Thursday League fees shall be used for Thursday social and golf events and for Thursday trophies. Division of money shall be made between 9 & 18 hole groups according to membership in each.
- (3) Revenue derived from the efforts of the Fundraising Committee and the invitational Tournament shall be applied toward course/capital improvements.
- (4) Revenue from raffles, 50/50's, tournaments, donations, and memorials shall be divided as follows:
 - a. Revenue derived from WGA club events shall become part of WGA Club funds.
 - b. Revenue derived from Thursday League events shall become part of Thursday League funds and shall be further divided between 9 & 18 hole groups according to group sponsoring event.
 - c. All privately donated revenue shall become a part of funds for WGA or Thursday League.

Section B

Budget shall list proposed revenue and proposed expenses by category and shall account for money on hand in bank.

- (1) Proposed budget shall be determined by Board of Directors and shall be presented to membership at April meeting and posted by May 1.
- (2) Any revisions to proposed budget must be authorized by Board of Directors and in turn be posted in women's locker room.

Section C

(3) All directors and chairmen shall be responsible for proper disbursements of their budgeted amounts. If director and chairmen determine she has insufficient funds to handle her events, she may request additional funds from the Board.

Administration of expenses shall be approved by the Board of Directors. Board to determine dollar amount overage then obtain membership vote.

- (1) Bills, invoices, or copies thereof from WGA and Thursday League shall be submitted to the Treasurer before expenses can be approved and paid.
- (2) WGA budgeted amounts and entry fees shall be turned over to Special Events Committee Chairman for their disbursement.
 - d. Committee chairmen are required to make full accounting of expenses and submit itemized paid receipts.
 - e. WGA funds should not be used to compensate volunteers working on any events.
 - f. Chairmen must fill out two "Evaluation Sheets" and distribute one to the Treasurer and one to the First Vice-President within three weeks of the event.
 - g. Any profits are to be turned in to the Treasurer.

ARTICLE VI

ACTIVITIES

All ties will require an eighteen-hole playoff to determine the winner. Tee Time(s) will be determined by players.

Section A

Tournaments

- (1) Match Play Tournament shall be determined by Board of Directors yearly whether it shall be played as a Club Event or incorporated into Thursday League, and dates and fees.
 - a. If match Play is played as a Club Event the following rules shall apply:
 - i. Participation is limited to WGA Members with handicap fee and WGA fee paid.
 - ii. Previous year member may use established handicap from previous year but must have 3 games posted in current year.
 - iii. New members with no previous handicap must have 5 games posted for current year by start of Match Play.
 - iv. Flighting of members shall be done by the Pro and handicap Director.
 - v. Any updating shall be determined by Board of Directors.
 - vi. Matches must be played within specified posted dates. Day and tee off times are to be made mutually agreeable to both parties. Players must notify opponent first or Pro Shop within one hour of tee off time of inability to play. Opponent shall wait one half hour after tee off time and if opponent does not show, match is forfeited.

- vii. Course rules and WGA match play rules shall govern play. If in doubt on a ruling, circle hole and on return to the Pro Shop obtain ruling from Pro. Match Play players may have option of playing in twosomes or playing as a foursome providing ALL are playing Match Play. All arrangements must be mutually agreeable to all players involved.
- viii. Trophies by Class shall be awarded at the October Awards Meeting.
- b. If Match Play is played as regular Thursday League play, the following rules shall apply:
 - i. Participation shall be limited to Thursday League members.
 - ii. Second Vice-Presidents (with Pro) shall schedule specific days, class pairing, and handicap all Thursday League players.
 - iii. Trophies by class shall be awarded at the October Awards Meeting.
- c. Handicaps will be frozen to the most recent handicap posted prior to Match Play.
- (2) Thursday League championship dates of play shall be determined by the Board of Directors.
 - a. Second Vice-Presidents, both 9 & 18 hole, shall flight and pair all eligible Thursday players. Flights will be adjusted according to handicap and number of golfers participating in each class.
 - b. Handicaps will be frozen to most recent handicap posted prior to Thursday League Championship.
 - c. To be eligible to play Thursday League Championship members must have:
 - i. All dues and fees paid.
 - ii. Have an established handicap from the previous season.
 - iii. New members must have turned in at least 5 Thursday League scorecards so that a handicap may be computed by the Pro.
 - iv. Second Vice-Presidents shall post complete playoff sheets and immediately after last day of play in tournament shall determine class winner and post.
 - v. Thursday League trophies, by class, shall be presented at the October Awards Meeting.

Section B

Club Events

- (1) April breakfast is open to all WGA members and is scheduled on Saturday date chosen by the Board of Directors.
 - a. April Breakfast is normally arranged by the incoming Board of Directors.
 - b. Members are required to make own reservations and are responsible for paying charges at door.

- c. Cancellation must be made 5 days in advance or member is liable for charge.
 - d. Members are urged to also pay their yearly dues and fees at this time, namely WGA dues, Handicap fee, Thursday League dues, and fees for Match Play.
 - e. Meeting shall follow breakfast and optional golf event may be played dependent on the weather.
- (2) Guest Day Club Event date shall be scheduled by Board of Directors, Chairman appointed by First Vice-President, and Chairman to select her committee.
- a. Guest Day Club Event is open to all WGA members.
 - b. Committee shall arrange breakfast, luncheon, format of play, pairings, and all details pertaining to same.
 - c. WGA funds shall be budgeted and used for this event and committee shall determine cost of lunch, prizes, favors, decorations, etc., and post entry fee.
 - d. Golf prizes will be awarded to guests only according to each guest's ranking in golf event.
 - e. Members shall be eligible for any door prizes or donations, 50/50's and raffles.
 - f. Any profit from guest Day shall be returned to the WGA.
 - g. Chairman must fill in Chairman Evaluation Sheet and place in file in women's locker room.
- (3) Field Day Club Event is open to all WGA members. Chairman appointed by Vice-President, and chairman to select her committee.
- a. Committee shall arrange all phases of Field Day, such as entry fee, sign-up sheets, golf format, pairings, dinner, and prizes and all details pertaining to same.
 - b. 9 & 18 hole golf shall be at discretion of the Golf Pro and Committee Chair.
 - c. All entry fees and WGA budgeted amount shall be turned over to committee for disbursement and committee shall be responsible for payments of dinner charges, prizes, decorations, favors, and expenses pertinent to the day.
 - d. Field Day is an optional day and members must pay entry fee by predetermined cut-off date in order to compete for prizes.
 - e. Golf prizes will be awarded at dinner and all golfers competing shall receive a prize. Member may attend only by paying appropriate charge.
 - f. All members attending dinner shall be eligible for raffles, 50/50's, and door prizes
 - g. Any profit made shall be returned to the WGA.
 - h. Chair is required to fill out two Chairman Evaluation sheets, one for the Treasurer and one for the First Vice-President.

Section C

Special Club Events

- (1) Decision to hold 18 HOLE INVITATIONAL TOURNAMENT shall be determined by Board each year and Board shall schedule date, appoint Chairman, and Chairman shall appoint committee.
 - a. This committee shall determine all rules, format of play, and social event with assistance from the Pro.
 - b. Invitational is open to a limited amount of members within specified handicap limit as bulk of field is reserved for outside clubs.
 - c. Invitational Tournament is entirely self-supporting. No money shall be budgets by WGA to defray costs.
 - d. Any profit made shall be returned to WGA for capital and course improvements.
 - e. Committee shall determine Entry Fee based on cost of breakfast, snack table, luncheon charges, prizes, decorations, favors, and expenses pertinent to the day.
 - f. All entry fees shall be received and dispersed by Committee.
 - g. Prizes shall be awarded to golf entrants at the luncheon.
 - h. Chairman is required to fill out two Chairman Evaluation Reports, one for the Treasurer and one for the First Vice-President.
- (2) An Annual Award Meeting will be scheduled two weeks following final Thursday League play. Trophy Chairman will chair this event.
 - a. All awards for League and WGA will be presented at this time.
 - b. Officers for following season are elected.
 - c. This event is open to all WGA members.
- (3) Weekend Events shall be scheduled and planned by Men's Committee and Women's Board and are open to all WGA members.
 - a. Specific sign-up sheets will be posted for members.
 - b. Pro shall schedule pairings and tee off times.
 - c. Some weekend events may be "Limited or Established" handicap and it is member's responsibility to check her own eligibility.
 - d. Member is liable for fee assessed.
 - e. 9-hole group shall also schedule golf events.

ARTICLE VII
