

FEEDING OF WATERFOWL RESOLUTION

WHEREAS, the undersigned are all the duly elected, qualified, and acting Directors of the Board of Directors of the Lakes of the Four Seasons Property Owners Association, Inc.; and

WHEREAS, one of the duties of said Board of Directors of the Lakes of the Four Seasons Property Owners Association, Inc. is to represent the best interest of the property owners and residents of the Lakes of the Four Seasons community, a planned unit development situated in Lake and Porter Counties, within the State of Indiana, including the preservation and improvement of the amenities belonging to Lakes of the Four Seasons Property Owners Association, Inc. i.e. the swimming pool, golf course, and lakes; and

WHEREAS, said Board of Directors of Lakes of the Four Seasons Property Owners Association, Inc. is concerned about the quality of the lakes within the community, particularly with regard to nutrient pollutants; and

WEREREAS, said Board of Directors of Lakes of the Four Seasons Property Owners Association, Inc. is aware that the habitation of the lakes by waterfowl causes certain nutrient pollution of the lakes; and

WHEREAS, the members of said Board of Directors of Lakes of the Four Seasons feel that the habitation of the lakes by such waterfowl is encouraged and increased by the feeding of such waterfowl by residents of the community; and

WHEREAS, members of the said Board of Directors of Lakes of the Four Seasons Property Owners Association, Inc. object to the feeding of such waterfowl by community residents;

NOW, THEREFORE, BE IT RESOELVED by the Board of Directors of Lakes of the Four Seasons Property Owners Association, Inc. that the feeding of such waterfowl is prohibited.

BE IT FURTHER RESOLVED by the Board of Directors of Lakes of the Four Seasons Property Owners Association, Inc. that any person or group found to be feeding or encouraging waterfowl to inhabit the lakes area of the Lakes of the Four Seasons community shall be subject to a fine of Twenty Five Dollars (\$25.00) for each offense and that each day of feeding or each feeding time shall be considered a separate offense subject to fine.

BE IT FURTHER RESOLVED by the Board of Directors of Lakes of the Four Seasons Property Owners Association, Inc. that any person or group found guilty of the offense of feeding said waterfowl on more than five occasions shall be subject to the suspension of the privileges of membership in the Lakes of the Four Seasons Property Owners Association, Inc.

BE IT FURTHER RESOLVED, by the Board of Directors of Lakes of the Four Seasons Property Owners Association, Inc. that any such fines which remain unpaid for more than sixty (60) days may be placed as a lien against the property owned by said person or group and foreclosed and collected in the same manner as a delinquent assessment.
